Whereas, a number of applicants after filling their application form in online mode are coming to the DM Office to submit their application form in offline mode as well;

Whereas, a number of applicants applying for renewal of their Arms Licences and other allied services are also coming to the submit their form in this Office in offline mode;

In view of the above, it is hereby ordered that all the applicants applying for new Arms Licence or renewal of Arms Licence or any allied service shall apply through the online portal only and that no offline application shall be entertained in this office. The applicant shall keep his application form in her/his possession for future reference.

Safe use and storage of firearms undertaking (as per form S-2) with proof, i.e. photograph of the locker / storage

Same formalities shall be required for renewal of licences or other allied services

Note:- The applicant shall submit his/her application form alongwith the above said documents only after the clearance of CID and Police verification of the applicant, which shall be intimated to the applicant accordingly. Further, the applicant shall also have to submit the following documents at the time of issuance of new licence, renewal of licence or any other allied service:

- 1. Four (4) passport size copies of the latest photograph of the applicant (in white background).
- Geo-tagged photograph of the applicant.
- The Licence Issuing authority i.e. District Magistrate Doda, at the time of issuing the New Arms Licence, renewal of licence or any other allied service can ask the applicant for any other document, if required.
